

## **ORDINANCE NO. 4**

### **AN ORDINANCE REGULATING THE MOVING OF BUILDINGS IN OR INTO THE TOWN OF EUREKA AND REQUIRING A SPECIAL PERMIT THEREFOR**

The Town Board of the Town of Eureka does hereby ordain:

#### **Section 1 - PERMIT**

- 1.1 The moving of any building or structure in the Town of Eureka, or the re-locating of any building or structure into the Town of Eureka is prohibited, unless a permit therefore shall first be obtained from the Town Board as provided in this Ordinance.

#### **Section 2 - APPLICATION**

- 2.1 The owner of the land upon or onto which any such building or structure is proposed to be moved or re-located shall file with the Town Clerk of the Town of Eureka a written application for permit setting forth the legal description of the real estate, the general description of the building or structure to be located thereon, the purpose for which said building or structure is to be used, the location at which said building can then be inspected, and the dimensions and estimated value thereof.

#### **Section 3 - FEES**

- 3.1 The application for permit shall be accompanied by an inspection fee of One hundred and fifty (\$150.00) dollars, said inspection fee being in addition to any building permit fee otherwise required. (Amended Ordinance 21)

#### **Section 4 - INSPECTION**

- 4.1 Any building or structure proposed to be moved into the Town of Eureka must be inspected by a certified building inspector and two Town Board members before a permit therefore be granted, and before the same be moved into the Town of Eureka. (Amended Ordinance 21)

**Section 5 - REQUIREMENTS**

5.1 No dwelling shall be moved from outside the Township into the Township unless approved by the Town Board and placed on a proper foundation before such permit be granted. The valuation of the appovement for building purposes shall be determined by the Town Board.

5.2 No one person shall be allowed to move into the Town of Eureka more than one residence within a period of 36 months unless specific approval be granted by the unanimous vote of the Town Board.

**Section 6 - VIOLATION.**

6.1 Any violation of this Ordinance shall be a misdemeanor and in the event that any person, firm or corporation moves a building or structure from outside the Town of Eureka into the Town of Eureka in violation of the terms of this Ordinance, each day that said structure or building is permitted to remain in the Town of Eureka in violation of this Ordinance shall constitute a separate offense.

**Section 7 - EFFECTIVE DATE**

7.1 This Ordinance shall take effect and force from the date after its passage and publication.
