## INTERCEPTOR (MUSA) LINE MEETINGS

Last year the Metropolitan Council Environmental Services (MCES) and Bonestroo Rosene Anderlik & Assc. studied and designed possible routes for a sanitary sewer pipe (interceptor line) to convey wastewater from fast-growing Elko-New Market area to an existing line in Lakeville for treatment at the MCES wastewater plant in Empire Township by 2010. (This unplanned growth is causing raw sewage overflow in the Vermillion River, affecting the river and many Eureka properties.) The pipeline is being directed through Eureka as it is more cost effective and to protect the Vermillion River Watershed.

An informational meeting was held in Eureka Township Aug. 2. Then our Supervisors and Planning Commission members met with the consultant, Met Council and Dakota County planner to obtain consistent information. There are now two options currently being advocated by MCES within Eureka: 1) 250th to Dodd Blvd. north to Lakeville, or 2) 245th to Dodd Blvd. north to Lakeville, both with a lift station at the intersection of 235th Street and Dodd Blvd; In 2030 there is an opportunity for Eureka to have access to the system by a proposal for a line from 235th Street East to Cedar Ave.

The Met Council will sponsor a public meeting at Eureka Town Hall in mid-November. Check the "Official Notices" box at the left for posting locations. All citizens are encouraged to attend this critical meeting.

## CURRENT TOWN BOARD ISSUES

*The Town Board is continually in the process of making decisions about Building Permits, Split Lots, Non-Conforming Use Permits, Conditional Use Permits, and issues that are not in compliance with our Ordinances. For specific information, refer to the minutes of Town Board Meetings on our website.*

### ELECTION OF TOWN BOARD SUPERVISORS:

Candidates wishing to run for Eureka Town Board Supervisor positions 3 & 4, may file for office with the Town Clerk beginning Tuesday, January 3, 2006 and ending Tuesday, January 17, 2006 at 5:00p.m. The election for these 3-year positions is March 14, 2006.

### NUISANCE OR NEIGHBOR COMPLAINTS

Occasionally residents send complaints, signed or unsigned, to the Town Board expecting them to resolve resident problems. Policing of the community and its ordinances is under the direct control of the County Sheriff's office. Use this procedure:

- 1) Issues must be reported immediately to the Sheriff's office. The Data Privacy Act keeps your name confidential at all government levels, and you must give your name, address and contact number along with your complaint.
- 2) You may notify the Town Board of your actions, also leaving your name address and contact number, so the Town Board is aware of the kind of problems encountered. The Township cannot follow up on a complaint if the complainant does not disclose the required information.
- 3) An official from the Sheriff's office will contact you in a timely manner.

## FARMLAND AND NATURAL AREA PROGRAM

The Dakota County Farmland and Natural Area Program (FNAP), funded through a voter-approved referendum in November 2002, works cooperatively with landowners to permanently protect productive, agricultural land to help sustain a thriving agricultural economy in the county. The program also works with landowners and a wide variety of partners to protect, restore, and connect threatened natural areas to ensure that the ecological, social, and financial benefits of these areas can be maintained and enhanced.

To date, FNAP has acquired six agricultural easements totaling 648 acres with the 124-acre Harmer easement in Eureka Township, delayed due to an existing pipeline restriction. Seven new farm owners are willing to sell agricultural easements on 1145 acres. Three natural areas totaling 95 acres have now been protected in Eagan and Rosemount, an additional 470 acres in Empire Township, and 12 acres in Lakeville will be protected by the end of November. Five other natural area projects, including two in Eureka, are in varying stages of progress.

A total of 37 land protection applications, totaling nearly 4,000 acres, were submitted during the latest application round which ended on September 16th, 2005. The majority of the 2003 and 2004 projects, when completed, have the potential to leverage additional funds from non-county sources totaling \$12,000,000, a significantly larger amount than the county land acquisition potential costs of slightly over \$7,500,000.

## DID YOU KNOW ABOUT EUREKA ORDINANCE.....

*These are quick ordinance synopses; for complete information, refer to Eureka Township Ordinances. They are available from the Town Clerk at \$25 for hard copy, \$2 for CD disk, or can be accessed on our website, or at Farmington or Lakeville Libraries, or Eureka Town Hall, or the County Law Library.*

**Ordinance 3: Zoning, Chapter 8 (p 74-77):** The purpose of **Signs on Private Property** is to protect the natural and scenic beauty of the roadside, protect property values and reduce potential traffic hazards. "No sign shall be erected, constructed, altered, rebuilt, or relocated, until a permit for the same has been issued by the Town Board." This includes business sales signs.

There are exceptions for name & address, decals, flags & emblems of public organizations, handicapped parking, private drive signs, government & utilities public signs, security and warning signs, temporary real estate signs, and garage/yard sale signs. However there are specific requirements and limitations of size or timing for these exceptions. Check out the details. Only official highway signs are allowed in the public right-of-way. Announcement signs, including political signs must be placed 20 feet back from your front lot line (or 53 feet back from the centerline of township roads).

**Ordinance 4: Public Safety, Chapter 4 (page 89-91):** Other than in lawful defense of person, family or property, necessary law enforcement, or shooting of predators, **Firearms** ordinances state:

- Shooting or carrying unencased firearms is prohibited, except a landowner and expressly invited guest may shoot within that property but not within 500 feet of any building or residence, nor to create a danger to other persons. Persons under the age of 18 must hold a firearms safety certificate recognized by Mn. Dept. of Conservation or be accompanied by a parent, guardian or adult with written parental permission.
- Persons cannot possess, control, carry firearms who in the previous five years have been convicted of a felony, weapons violation, committed to mental, drug, alcoholic institutions or while under the influence of drugs and alcohol.
- Except in conformance with a validly issued state permit, carrying & transporting hand guns is unlawful other than at one's own residence.
- Possession and transporting of assault weapons is unlawful for any purpose whatever.

**Ordinance 4: Public Safety, Chapter 2, Section 18B (page 88):** A reminder about **Snow Plowing** when the snow starts to pile up. It is illegal and punishable as a misdemeanor to plow, shovel, blow, or place snow onto Township roadways, or other **obstructions** in the right-of-way such as rocks, vehicles, piled materials, etc. (see **Ordinance 4, Chapter 2, Section 6 (page 85)**).

Junk Automobiles. No boats, farm equipment or buses.

Any junk vehicle, some farm machinery, scrap metal.

Will pick up for free. If junk is brought to Cedar
