PLANNING COMMISSION MESSAGE by Cory Behrendt

Curtain Call.....Enter Eureka Township, stage left:

We have rehearsed our parts and as of January 9th we are in full production of setting the vision for Eureka Township. The RFP to hire a planner for our Township has been approved and has been distributed to many consultants in the field. Over the coming months we will be receiving responses and selecting a consultant who will guide us through the development of a Strategic Vision.

Based on our current timeline, we expect the contract will be awarded by June and the process will begin shortly thereafter. The first Phase includes an innovative and extensive public participation program, which will be led by the consultant. This is the critical element to our strategic vision as it will build from the Townships collective vision. During this Phase the consultant will lead the Township through multiple public input forums to collect information about our visions for Eureka.

What is your part? It will be important to be a part of our public forums to voice your opinions, concerns and thoughts about our future. It will be from this public input that a strategic vision will be created. The strategic vision will include zoning guides for our future, input to our next comprehensive plan, land use maps and other tools to help make key decisions.

We have seen the winds of change surround us. If we do not chart our course carefully and strategically, we may not be able to set a course at all. Also remember that we must agree collectively as a Township. This means there will be compromises to be made and differences to be settled. Lets agree to build Eureka as friends and neighbors.

TOWN BOARD ISSUES REVIEW 2005

The Town Board is continually in the process of making decisions about Building Permits, Split Lots, Non-Conforming Use Permits, Conditional Use Permits, and issues that are not in compliance with our Ordinances. For specific information, refer to the minutes of Town Board Meetings on our website.

The Town Board and Planning Commission engaged in many regular and special meetings, training, inspections, and research to conduct the business of the township. They also handled an array of written complaints this year regarding junk vehicles, derelict buildings, noise, and right of way issues, some of which can result in misdemeanor actions if ignored. In 2005 there were 30 building permits approved, 10 lot splits approved with county registration essential, and registration of 21 non-conforming businesses by the Dec. 31, 2004 deadline (Zoning Ordinance 3, Section 5, page 38-40). See Clerk/Treasurer for detailed information.

Connie Anderson, the Town Board Chair, submitted her resignation for personal reasons effective March 24, 2006, so that her remaining term of 1 year will be on the March ballot. Her extensive service to the community and recent historical memory of town board functioning will be difficult to replace. A big thank you should go to all elected, appointed officials, paid staff, and volunteers of the Township for their many hours of effort on our behalf.

The North Cannon Watershed Management Organization model ordinance for erosion control and storm water management requirement for land disturbances may be adopted into our ordinances. If the Town Board makes this recommendation, established processes will be used including a future public hearing which would be noticed in the Life and Times newspapers.

DID YOU KNOW ABOUT EUREKA ORDINANCE.....

This is a quick ordinance synopsis; for complete information, refer to Eureka Township Ordinances. They are available from the Town Clerk at \$25 for hard copy, \$2 for CD disk, or can be accessed on our website, or at Farmington or Lakeville Libraries, or Eureka Town Hall, or the County Law Library.

Eureka Township is zoned as an **agricultural district**. **Permitted uses** (as specifically defined by the Ordinance) include such things as commercial agriculture and horticulture, farm buildings, forestry, grazing and gardening, one single dwelling unit per each quarter-quarter section, historic sites, home occupations and private stable.

Conditional Uses and Structures may be approved if certain provisions and requirements are met. They could include government facilities, churches, cemeteries, airports, schools, mining and extraction operations (following Mining Ordinance requirements), public utility/service structures. "All other uses and structures which are not specifically permitted as a right or by Conditional Use Permit, including public stables and boarding of dogs, shall be prohibited in the Agricultural District." {Eureka Township Ordinances, 2005; Ordinance 3, Chapter 2; Section 1, page 40}

A **Conditional Use** may be appropriate or desirable but may create special problems (i.e. height, bulk, traffic congestion) so that not all locations might be suitable or in the best interest of the community. (definition, page 8)

A **Conditional Use Permit (CUP)** may be granted depending on the effect of the proposed use on health, safety, morals, and general welfare of occupants of surrounding lands and water bodies. It must not be in conflict with the Comprehensive Plan and be consistent with the Zoning Ordinance. Numerous findings are required by the Planning Commission and the Town Board. A public hearing is required. Standards and requirements may be imposed to protect public health, safety and welfare. A permit specifies the specific conditions of use and is reviewed periodically. (Ordinance 3, Chapter 4, Section 13, pages 61-64) **Recording of a Conditional Use Permit:** "A certified copy of any conditional use permit shall be recorded with the county recorder or registrar of titles of the county or counties in which the municipality is located for record. The conditional use permit shall include the legal description of the property included." (Minnesota Statutes 2005, Chapter 462, 462.3595, Subd. 4)

The public is invited to comment favorably or unfavorably during this review to extend or revoke the CUP. In 2006 the following Conditional Use Permits will come up for review at regular Town Board meetings as follows:
