Vermillion River Watershed Joint Powers Organization

What is the Vermillion River Watershed?

With 335 square miles of land that drain to the Vermillion River and its tributaries, the Vermillion River Watershed is the largest in area among watersheds in the Twin Cities Metropolitan area. It passes through “areas of rapid urban growth, agricultural land and suburban residential land” in Scott and Dakota Counties and contains the only “world class trout stream within a major metropolitan area in the United States.”

What is the Vermillion River Watershed Joint Powers Organization?

Dakota and Scott Counties formed the Vermillion River Watershed Joint Powers Organization (VRWJPO) in 2000, replacing the earlier Watershed Management Organization (WMO). When the earlier WMO was dissolved, State statute required the responsibility for water planning and management to be taken up by the Counties. After forming the new Joint Powers Organization, a new Watershed Plan was developed and adopted in 2005, leading the development of policies, programs, and projects that protect and preserve water resources in the Vermillion Watershed. The VRWJPO is governed by a three-member Joint Powers Board. A nine-member citizen advisory Watershed Planning Commission supports the Joint Powers Organization. Dakota and Scott Counties jointly fund the administration and activities of the VRWJPO through a levy in a “special purpose” tax district.

What is the history of the VRWJPO Plan, Standards and Rules?

The overall goal of the **Watershed Plan** is to protect water quality and quantity by gradually implementing river-friendly land use practices to previously impacted lands or land-use changes in the watershed originating from development. It was adopted in November, 2005. The **Watershed Standards**, adopted on February 27, 2008, are a minor amendment to the Plan and published as a companion document to the Plan. The **Watershed Rules** are the implementation mechanism for the Standards at the watershed level, similar to local ordinances, and govern certain land use and alteration activities within the Vermillion River Watershed.

Where does Eureka stand on the adoption of the Watershed Plan, Standards and Rules?

We are currently in a kind of limbo. The Eureka Town Board responded to citizen input and adopted a Local Water Management Plan but did not adopt a Water Management Ordinance (which would implement the Watershed Standards). However, this does not mean that the Watershed Rules do not affect us. The citizens of the Township who live in the Vermillion Watershed, are obligated to abide by the Watershed Rules. Without a Township Ordinance, enforcement and permitting of the Watershed Rules would come from the VRWJPO (located in the Dakota County Govt. Center in Apple Valley) and not locally from the Township.

The VRWJPO Plan has been amended, partly in response to Eureka’s concerns over buffer requirements and conservation easements. What changed?

Many of the situations that would have triggered the need for buffers along waterways and wetlands no longer apply to our Township as long as we keep housing density at one home per quarter-quarter-section and are not clustering building eligibility along waterways and wetlands.

What kind of practical effect does this have on me if I have property along an affected parcel?

The amendment provides that a lot split for an existing building eligibility available under the one per quarter per quarter zoning *would be exempted* from the requirement to establish

the buffer through conservation easement. The proposed building *would need to meet setbacks* so that there would be no physical encroachment into the “buffer” area, but *no buffer would need to be planted, nor would an easement be required.*

What would trigger the buffer and conservation easement now?

The exemption applies only to the eligibility within that quarter-quarter. A lot split to accommodate an eligibility transferred from another area would need to establish the buffer through conservation easement (for example in the case of clustering), but only in the new lot that is being created. A split of an existing lot of record that is not eligible for this or other exemptions would also be required to establish the buffer at the time the lot is split.

Wild Parsnips Alert!

Township ditches and fields are again producing a fine crop of wild parsnips. When the sap of the plant comes in contact with skin in the presence of UV light (present on sunny days or cloudy ones), it can cause a rash, blistering and discoloration of the skin. The plant can grow to three feet or taller, has lacy yellow flowers and is often mistaken for dill. CapX2020 Power Line – In May 2010, Administrative Law Judge Luis forwarded to the Minnesota Public Utilities Commission (PUC) his conclusions for the route of the high voltage power line. It appears a modified version of the earlier identified “preferred route” through the center portion of Eureka Township has been recommended for the Brookings to Hampton section. The PUC has not yet issued a routing permit and the utilities involved in this section of the project have asked for a delay until 2015, in part, to determine how the project will be funded. The Minnesota Court of Appeals ruled against Citizens Energy Task Force (CETF) and others in early June 2010, paving the way for the Hampton to LaCrosse portion of the project to move forward, possibly as early as Fall 2010. Eminent Domain – On April 30, 2010, Governor Tim Pawlenty signed legislation designed to “increase fairness for Minnesota landowners involved in the eminent domain process with utility companies.” The increased protections for landowners include language regarding compensation for attorney bills, appraisals, negotiations, notice, loss of “growing concerns”, and relocation. This will provide additional assistance for those landowners should the CAPX 2020 project move forward.

Ordinance Updates – The Board adopted the June 14, 2010 document and those Ordinance changes went into effect on July 9, 2010. Those changes include, but are not limited to, definition changes throughout, Ordinance 3 – Zoning (clustering, junk vehicles, manufactured homes), Ordinance 4 – Public Safety (utility installation), Ordinance 6 – Mining, and Ordinance 7 – Fees. 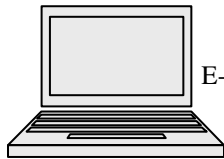

DAKOTA COUNTY HAPPENINGS

Capital Improvement Plan Impacts Eureka – Dakota County has released its 2010 – 2014 Capital Improvement Plan, which contains three major road projects for Eureka Township. Among these are upgrading County Road 80/255th St. to a two-lane State Aid highway from County Road 23 (Cedar/Galaxie/Gambier) to Highway 3, including modifying/reconstructing the railroad bridge. Also being rebuilt is County Road 9/Dodd Blvd., including shoulders and turn lanes, from County Road 46/2 in Scott County to County Road 70/215th St. County participation in this project is contingent upon the receipt of Federal funding. A third project is the creation of a two-lane paved road on County Road 84/267th St. from the Scott/Dakota County line to County Road 17/Highview Ave. Landowners involved in all projects will receive notice of public meetings during the design phase of each project. No local cost share or assessments are expected.
