The 2010 Annual Election and Town Meeting were held on Tuesday, March 9. With 132 total votes cast, the results of the election are Kenny Miller - 70 votes, Chris Prose - 56 votes, Write in - 6 votes. The canvassing board met on Thursday, March 11, 2010, to officially declare Kenny Miller as the next Town Board Supervisor, term to run through March 2013.

The 2010 Annual Meeting began at approximately 8:15 p.m. with the Pledge of Allegiance, followed by the election of Cory Behrendt as moderator.

Chair, Vince Mako recapped the Planning Commission top agenda items:

Township's Comprehensive Plan

Ordinance review and updates

Preparation for the upcoming Commercial-Industrial task force

Jeff Otto, Chair of the Town Board, included the following information:

Roads – In 2009 - Four miles of Township roads were graveled, \$31,000 in dust control was applied (aiding in the long-term viability of the gravel), and 225th St. was rebuilt where it crosses the Vermillion River.

2010 possible paving of part of 225th St. due to additional hangar construction

2013 plan to repave Dodd Boulevard by Dakota County

2014 possible realignment of Cedar Ave. to accommodate runway extension

Vermillion River Watershed Joint Powers Organization (VRWJPO)

Eureka rejected the burden of enforcement of the ordinance, which will now fall to the County and Soil and Water Conservation District (SWCD) which has the staff, resources and expertise to oversee the legislation. This has become a model for other Dakota County Townships.

Ordinance Updates – The 1990 Clustering Ordinance needs reworking as it contradicts the 1 on 40 zoning in the Township. Continue work on lots identified as having grand-fathered building site eligibility. Clarify requirement to rebuild on current sites within 12 months when original structure has been destroyed. Update the Road Haul ordinance.

CapX2020 – High voltage power line project continues with Eureka being impacted by both the preferred route (primarily 240th St.) and the alternate route (basically County Road 86). As an aside to this issue, the Minnesota Legislature is, again, considering removing the current exemptions of utility companies to the Eminent Domain law.

Country Stone Litigation – A CD of approximately 700 pages of testimony is available for the cost of \$5.00. Please contact the Town Clerk if interested.

Commercial – Industrial Task Force – TKDA has been identified as the facilitators for this body. Additional Eureka residents and landowners are being sought to serve. \$15,000 of the expense will come from the negotiated settlement of the Hat Trick Property annexation by Lakeville.

2011 Levy set - \$465,000.00 (decrease of \$15,000 from 2010)

General Fund \$164,700

Road and Bridge Fund \$230,000

Hard Road Surface Escrow \$17,300

Town Hall Fund \$53,000 (Mortgage Reduction)

It is anticipated that through unallotment, the State will reduce its aid to Eureka by \$13,700 in the coming year (up from over \$7,000 last year). In another change, those in attendance at the Annual Meeting voted to eliminate the yearly \$15,000 contribution to the Professional Services Escrow Fund for 2011.

CapX2020 Power Line - The Minnesota Court of Appeals heard arguments on March 17, 2010, challenging last August's decision by the Minnesota Public Utilities Commission (PUC) to approve the Certificates of Need for the project. No date has been identified for the decision by the Court.

Country Stone /Friedges Litigation - CD's of the court testimony to March 2010 are available for \$5.00. Please contact the Town Clerk for more information.

Eminent Domain - The Minnesota State Legislature has taken up the issue of removing the special exemptions for public service companies (utilities) in the current Minnesota Eminent Domain law. To date, bills have passed both the House and Senate and are in conference committee to iron out the differences between the two versions of the bill.

Interceptor Sewer Line - This project continues and will include short-term road closures on 225th east of Dodd Blvd. and Dodd Blvd. north of 225th during May and/or June. More specific information will be posted on the Township website as it becomes available.

Vermillion River Watershed - Meetings and discussion between the Township and the VRWJPO on the possibility of dual permitting continue, including an agenda item for the May 10 Town Board meeting. A VRWJPO public hearing for final comments on and the adoption of the amendments to the Watershed Standards will be held at 1:00 p.m. on Thursday, May 27, 2010 at the Dakota County Western Service Center, Conference Room 334, 14955 Galaxie Ave., Apple Valley. Contact the Town Clerk for further details on viewing the draft amendments and opportunity for written and oral comment.

How Permit Fees are Calculated

My permit fee is based on the project Valuation. Why is that?

MN Rules Chapter 1300.0160 Subpart 4: “**Building Permit Fees shall be based on Valuation.**

Exceptions:

- A. One and two-family dwelling maintenance permits for roofing, siding, windows, doors or other minor projects may be charged a fixed fee.
- B. Permits for plumbing, mechanical, electrical, or other building service equipment may be based on valuation or changed a fixed fee.”

Why do I need to supply the Valuation on the permit application?

MN Rules Chapter 1300.0160 Subpart 3: “The **applicant** for a permit shall provide an estimated permit value at time of application. Permit Valuations shall include total value of **all** construction work, **including materials and labor**, for which the permit is being issued...”

The Building Official changed my valuation to a higher number. Why?

MN Rules Chapter 1300.0160 Subpart 3: “...Building permit valuation shall be set by the building official.” *In order to treat everyone fairly, the supplied valuation is used with a minimum of a calculated valuation based on the State Valuation Tables.*

So how does the Valuation translate to the permit fee?

MN Rules Chapter 1300.0160 Subpart 1: “The applicant for a permit for a building; structure; or electrical, gas, mechanical or plumbing system or alteration requiring a permit shall pay the fee set forth by a fee schedule adopted by the municipality.”

What are all the fees that might apply to my permit?

Permit Fee: Based on the above valuation calculation or fixed fee from fee schedule.

Plan Review Fee: Based on 65% of the permit fee when submittal documents are required.

State Surcharge: This is like a sales tax, and is not part of the Municipality’s fee schedule.

Other Fees: Miscellaneous fees like copy charges, site inspections, SEC, or other fees.

Municipality Fees not calculated by us: Sewer, Water, Sewer Access charges, Water Access charges, Park Dedication fees, Zoning fees, Application fees, etc.

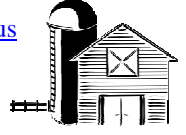
