Election Results

As the polls opened on March 8, 2011, the voting record listed 1,006 registered voters in Eureka Township. Four voters registered at the polls that day, bringing the total number of voters to 1010. 272 total votes were cast in the 2011 Annual Election, including nine absentee ballots, for a turn out of about 27%.

The results of the 2011 Township election are as follows:

Annual Meeting

Cory Behrendt was elected moderator of the 2011 Annual Meeting, held at the Eureka Town Hall at 8:15 p.m. on Tuesday, March 8.

Ken Olstad, Planning Commission Chair, presented an overview of 2010 events.

- Ten building permits were issued in the Township.
- The Comprehensive Plan was completed and accepted by the Metropolitan Council. Many were thanked for their hard work on this document, with special note made of the contributions of Sharon Buckley and Jim Sauber.
- Ordinance updates included Clustering and Building Eligibility rules, Subdivision, Swimming Pools and Dog Kennels.
- Please note the Planning Commission is looking for one more member.

Brian Budenski, Town Board Chair, provided the Board overview. Appreciation was expressed for the Power Point presentation created by Board member Carrie Jennings.

- Roads – The rebuilding of the Chub Lake crossing will take place in 2011, including replacing the non-functioning culverts. Anticipated cost will be between \$20,000 and \$25,000.
- Fire/Rescue Service – In 2010, Farmington charged \$53,167 for 20 calls and Lakeville charged \$33,240 for 27 calls. The Board is looking into recovering some costs for calls related to illegal items such as burning without a permit, burning barrels, multiple false alarms.
- Vermillion River Watershed Joint Powers Organization – Eureka adopted the plan put forth by the VRWJPO, but did not adopt the ordinance, thereby leaving the VRWJPO to administer the ordinance. Please note the changes that have resulted to the building permit application process under “Notes from the Town Clerk”, later in this newsletter.
- Levy – the 2012 levy of \$479,800 was approved by voice vote after removing \$10,000 for professional services. The levy provides an increase for fire coverage.

The 2012 Annual Town Meeting was scheduled for Tuesday, March 13, 2012, 8:15 p.m. The 2011 Town Meeting was then adjourned at 9:20 p.m.

CAPX2020 – The final decision regarding the routing of the high voltage power line was made with the announcement of Belle Plaine river crossing. Easement purchase will begin this year, with field construction scheduled to begin in 2012 and completion slated for 2015. The line will pass through the entire width of Eureka Township from the western border to the eastern.

General Notice to Control or Eradicate Noxious Weeds

State statute requires residents to control or eradicate all noxious weeds on property they own, occupy, or are required to maintain. This must be done in a lawful manner and may need to be repeated in order to prevent the spread of seed, or other propagation methods, to other lands.

Major Change to Permit Application Process

Residents are advised that **effective immediately**, requesting building permits for property that lies in the Vermillion Watershed District (approximately the northern two-thirds of the Township from County Road 84 on the west side to County Road 80 on the East side) in which land disturbance may occur, must apply **FIRST** to the VRWJPO **BEFORE** applying to the Township.

Permits Required from the VRWJPO – construction that changes the footprint of an existing building, or any additional building or land disturbance, lot splits and subdivision approvals. This includes pools and decks. Additional fees will apply in all cases.

Permits not required from the VRWJPO – re-roof, re-side, new windows, plumbing, heating, interior remodeling.

Permit waiting time may increase – After a properly completed permit application is received by the VRWJPO, it has up to 60 days to act upon the request, although every attempt will be made to expedite the process. The ruling VRWJPO Board usually meets the 4th Thursday, 1 p.m. (contact the VRWJPO) at the Western Service Center in Apple Valley. After approval is received from the VRWJPO, the permit may then be taken to the Township, which also has up to 60 additional days to act upon the request.

Shoreland/Floodplain Zoning – in some cases, land that falls within the jurisdiction of the VRWJPO also falls within the Shoreland/Floodplain zoning, for which a separate permit may be required, further extending the wait time for permit approval.

The responsibility for properly completing a permit application lies squarely on the applicant.

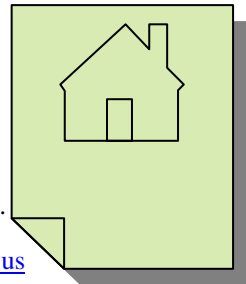
