Change in Township Newsletter Delivery

The Eureka Township newsletter, *Eureka! The News*, has been a familiar goldenrod colored pamphlet delivered to the mailboxes of residents and property owners for nearly 10 years. Beginning in January 2015 that pamphlet will no longer appear. In September 2014, a decision was made by the Town Board to change the method of delivery from the U.S. Postal Service Bulk Mail to a primarily electronic method. With the next edition, you will have the following options in order to receive the quarterly newsletter:

Township Road Committee – Volunteers Needed

The Town Board is forming a new Road Committee, expected to include the two road supervisors, a road contractor, one Planning Commission member and up to three citizen volunteers. The entire committee will be volunteer and meet 4-6 times a year. Work would include creating a detailed road budget, capital improvement projects, road maintenance and general road planning. Any interested applicants should submit a brief letter of interest to the Town Clerk. Applicants would need to attend a Town Board meeting, to be interviewed and appointed. The term would last for one year and applicants may re-apply for additional terms.

Minnesota voters may register to vote on Election Day. To register at your polling location, you must provide proof of residence, complete a voter registration application, and sign an oath stating that you are eligible to vote in the precinct.

Township Storage In With the New - Out With the Old

The new Township storage building on the site of the “new Town Hall” has been substantially completed. Once the Conex shipping container that served as the previous storage facility has been removed from the site, final grading, lawn seeding and landscaping can occur.

At the October 14, 2014 meeting the Town Board announced it had received four offers to purchase the Conex storage container. Of the four received, the highest one of \$1,400 from Terpstra Snowplowing and Lawn Care was accepted. It is hoped the Conex container will be removed from the current location by the end of October.

Dodd Boulevard Construction Update

Dakota County Road 9 (Dodd Boulevard) between 240th Street and 235th Street is closed to through traffic as of Monday, October 13, 2014 for the replacement of the Vermillion River bridge. This closure will remain in place for approximately one month. Access to residences will remain open throughout construction; however, access will be limited to only one direction until the bridge replacement is complete. Traffic will be detoured using Dakota County Roads 80, 23, and 70.

Work yet this fall on the portion of County Road 9 (Dodd Boulevard) through Eureka Township is expected to include:

- Tree removal as necessary.
- Removing the existing pavement between 240th Street and 235th Street.
- Private utility work.



The 2015 construction season will include the reconstruction of Dakota County Road 9 and Scott County Road 2 east of the new roundabout. The reconstructed roadway will be a little wider than the existing roadway, but it will still be a two-lane road. Turn lanes or bypass lanes will be added at intersections and the shoulders will be paved. Construction is expected to be completed by November 2015, weather and unforeseen circumstances permitting.

Snow Plowing Season Just Around the Corner!

As much as we'd like to delay or eliminate the snow plowing season, chances are very good it will arrive sooner rather than later. Below are some things to keep in mind during what can be a challenging time.

1. Patience is requested – All roads cannot be plowed at the same time. *After* a normal snowfall, it takes approximately five hours to plow Township roads, barring complications.
2. There is a priority list determining which roads get plowed first, primarily based on population density. The northwest quadrant (northwest of the intersection of Cedar and 250th St.) is the most densely populated and is therefore, the first to receive attention. Connector roads leading traffic to larger roads are also likely to have a higher priority. ***Please note – if you are an emergency care provider, please notify the Town Clerk at 952-469-3736 or eurekatn@frontiernet.net.**
3. ***“It is illegal and punishable as a misdemeanor to plow, shovel, blow, or place snow onto Township roadways.”*** Similar rules apply on County and State roads. A number of residents have been plowing out their driveways by pushing the snow across roads. This has been causing difficulties and delays for the road plows, especially this year where the size of snow piles has been so large and difficult to move off the roads and right of ways. Snow from your property should be plowed and stored on your own property and not pushed across roads.
4. Use common sense and have regard for your safety and that of others. When no travel is advised, stay off the roads. If County or State snow plows have been pulled off the roads, stay off the roads. If Metro Transit stops bus service, stay off the roads. Not only is this a safety concern, but a plowing concern. If vehicles are stuck in the road way, plows may not be able to get through, causing delays in the plowing schedule as well as increasing the plowing costs.
