PLANNING FOR THE FUTURE: CREATING A STRATEGIC VISION FOR EUREKA by Eurela Township Planning Commission

As usual for this time of year, the planning commission has had a busy few months. In April, we welcomed two new members-Sharon Buckley and Nancy Sauber-and bid farewell to long-time member Francie Madden, as well as our chair Cory Behrendt. We've also handled the usual spring onslaught of building permit requests, conducted public hearings on several proposals to change township ordinances, and worked to improve our administrative procedures.

But our most exciting work has been completing the search for a planning consultant, which Eureka citizens first requested at the 2004 annual meeting. After interviewing three firms who replied to a request for proposals, the planning commission recommended the township contract with McCombs Frank Roos Associates, a firm based in Plymouth. Bill Weber, a consultant with 30 years experience in rural planning, will be the principal for the project.

The planning commission's goal in working with the consultant is to create a township-wide, citizen-based strategic vision for Eureka that can help guide the township's next comprehensive plan update, which is due to the Metropolitan Council in 2008. Without a shared vision based on what we value about our community, there is a real risk that future growth in Eureka will be haphazard, inefficient, and dictated by the needs of developers, not the interests of the township or its residents. The planning commission believes that by creating a shared vision, we can enjoy the benefits of growth and ensure that future development preserves those unique features that make Eureka a special place to live, work, and raise a family.

Ultimately, the key to the success of the strategic visioning process is citizens like you. We want to know what citizens have to say: what you value about Eureka, what you would change, and where you want the community to go. Of course, we also realize that not everyone has the time to devote to following township business. That's why we've designed the strategic visioning process to provide many different opportunities for public input: through a citizen advisory committee that will steer the process, public forums and open houses, a township opinion survey, website announcements, and periodic mailings.

We hope that everyone with an interest in the future of our community will find ways to participate in the strategic visioning process. For those who would like to serve on the citizen advisory committee that will guide the process, we encourage you to read the call for applications on page 2 of this newsletter. MESSAGE FROM TOWN BOARD CHAIR, CORY BEHRENDT

Here we are just past the summer solstice 2006 and with the year half over; the Township continues to work through many difficult issues. We currently have three public utility projects in motion, two Watersheds at different stages of implementing rules and regulations, and one Township struggling to deal with the impacts and pressures of change. Information on all of these issues is available at the Town Hall. The following are a few updates and resources to be familiar with for each of the issues:

<u>Elko-New Market Sanitary Sewer Interceptor</u> - This project will be completed in three segments over the next 3 years. Construction has started with the County Road 2 project and construction will move into our Township beginning next summer. Citizens are being contacted to establish the required easements.

MinnCan Crude Oil Pipeline Project - This project is moving toward final route hearings and approval of the Routing Permit tentatively scheduled in August or September. **NOTE**: Citizens are not required to entertain proposed routes or agree to any easement terms until the Routing Permit has been issued. This permit will document the approved route.

Northern Lights Natural Gas Project - This project is nearing federal approval and is planned to be completed and in service on Nov. 1, 2007.

<u>Vermillion River Watershed Joint Powers Organization</u> - The VRWJPO is currently working on proposing rules and regulations intended to protect the environmental stability of the Vermillion River. A significant impact being proposed is the implementation of required buffers which will limit use on citizen's properties next to waterways in the Vermillion Watershed from 40' to 300' in some places. It also includes the use of Storm Water Pollution Prevention Plans similar to the newly adopted North Cannon River Watershed ordinance. The VRWJPO is working to adopt these rules and will then require adoption tentatively by the end of 2006.

New Watershed Ordinance SWPPP - Please be aware this ordinance has been adopted and requires projects that, in general, disturb land greater than 1 acre must apply for a Storm Water Pollution Prevention Plan Permit. Please refer to the newly adopted ordinance for specific details.

As you can see this is a lot of information to be aware of, including the potential for significant change of land use for certain citizens. The Township will continue to work through these issues and asks that citizens continue to provide feedback and input. Many of these issues have already provided significant challenges and frustrations, but can only be resolved through continued dialog. We have heard the call from the Township to become more active in providing reasonable solutions to land owners in light of the many issues that surround us. The most important piece to our future is continuous citizen input which must be highly regarded.

STRATEGIC VISIONING CITIZEN ADVISORY COMMITTEE: Call for Applicants

Eureka Township invites applications from individuals who wish to serve on the Township's Strategic Visioning Citizen Advisory Committee (CAC). The CAC will act in an advisory capacity to the Eureka Planning Commission, and will formulate a broad strategic vision to help guide future planning for Eureka in preparation for the Township's 2008 Comprehensive Plan update.

The committee will meet approximately 5-6 times and conduct two public open houses during the course of the next 9-12 months. All meetings will be on weekday evenings, with the first meeting taking place sometime after September 11. Ideally the CAC will include a broad cross-section of Eureka Township. Applicants must be current residents or landowners in the township, must be able to commit to attending all meetings and open houses, should have knowledge of and interest in the future of the community, and must have good communication skills and the ability to work well in groups.

Applicants will be interviewed by the Eureka Planning Commission during the week of August 21, 2006. A Township representative will contact each applicant to schedule an appointment for the interview. Applicants must attend the interview to be considered for the advisory committee. Applicants chosen for the CAC will be appointed by the Town Board at the Board's September 11, 2006, meeting.

Job position open: Deputy Clerk/ Treasurer:

NEW POLICY FOR BUILDING PERMIT APPLICATIONS

- To give commissioners more time to evaluate application requests, the Planning Commission has adopted a new policy for processing applications. For building permit, land split, cluster, or other land use requests to be placed on the agenda for consideration at a Planning Commission meeting, a complete application must be received by Monday at noon, one week before the Planning Commission meeting.
- Applications received after this deadline will not be acted on until the following month's meeting. Please plan ahead to ensure your application is complete and submitted on time.
