The 2008 Township election was held on Tuesday, March 11. 220 voters cast their ballots. Results were canvassed on March 13 and are as follows:

Thanks go to John for a job well done. The 2009 Township levy was set at \$480,000. The 2009 annual meeting is scheduled for Tuesday, March 10, 2009 at 8:15 p.m. in the Town Hall.

Mrs. Belzer has always been well prepared, putting in countless hours of research, and acting as a strong advocate for Eureka Township, serving as Town Board contact for communications, sheriff, wetlands and North Cannon River Watershed (along with Supervisor Behrendt). TOWN BOARD NEWS

A message from retiring Town Board Supervisor Gloria Belzer - As my term has ended as Town Board Supervisor, I would like to take this opportunity to thank the citizens of Eureka for their vote of confidence and support in allowing me the privilege and honor of serving this community. I found the responsibility of addressing issues and balancing the needs of individual citizens with the well being of the whole community both challenging and rewarding. I will continue to dedicate my time to a community I am proud to be a part of.

PROJECT UPDATES

Elko-New Market Interceptor – http://metrocouncil.org/environment/CapitalProjects/cip-8016.htm Construction on this project is currently underway on Dodd Boulevard. Drivers along Dodd are cautioned to SLOW DOWN dramatically, as lane closures are common, and shoulder space is limited. The project will continue throughout the summer.

Northern Natural Gas Pipeline – Work on this pipeline has been substantially completed with the exception of an area on 245th St. where work will continue in 2008.

MinnCan Project - http://energyfacilities.puc.state.mn.us/Docket.html?id=18339 MinnCan reports that actual pipeline construction in McLeod, Carver, Sibley, Scott and Dakota counties is scheduled to begin in April and run through late 2008. No actual construction has begun in Eureka at this date. Assuming the project remains on schedule, Larry Van Horn, vice president for Operations of the Minnesota Pipeline Company, states a late 2008 completion date is anticipated, at which time 165,000 barrels of Canadian crude oil are expected to be transported daily. The first hearing by the Minnesota Court of Appeals regarding the *Petition for Reconsideration* and *Petition for Rehearing* was held at the Minnesota State Court of Appeals on March 13, 2008. A decision is expected within 120 days. Landowners with property being taken under eminent domain will begin hearings with court appointed commissioners in May.

CAP X 2020 Project - http://energyfacilities.puc.state.mn.us/Docket.html?Id=19120. This project is in the "need" phase and will enter the "planning phase" throughout 2008. The Citizens Energy Task Force met on April 15th and decided to hire an attorney to help increase CETF's effectiveness in the contested case hearing for the CapX permitting process. Paula Maccabee, independent lawyer and public interest advocate is highly experienced with the PUC and landowners rights. But money must be raised for this purpose and time is of the essence. CETF learned that in 2006, Statute 117.189 created eminent domain exceptions that significantly favor CapX negotiations with property owners and which even the state and counties do not have in these kinds of proceedings. A bill was introduced to remove these exceptions but, according to one of the sponsors, will probably not make it to the floor for this session. CETF will mobilize to work on this issue and to try to revive the bill, if possible. We urge citizens to contact us and to get involved and consider donating money to help us work to get back the property owner rights we need to negotiate for all public service projects, and other issues such as need justification, affecting the type of generation, and the carbon footprint of the lines. TOWNSHIP ROADS

Eureka Township is responsible for 38 ½ miles of gravel roads within the Township borders, and is in the process of creating a five year plan for ongoing road maintenance. The proposed 2008 gravel & limestone projects include:

- *225th St. Cedar Ave. to Flagstaff Ave.
- *Hamburg Ave. 225th St. to 240th St. and South of 267th St. (ditch reconstruction with \$5,000 from NCWSD)
- *245th St. Fordham Ave. to Essex Ave.
- *Iberia Ave. south

In addition, a motion was made, seconded and carried at the 2008 Annual Meeting asking the Town Board to look into paying "aprons" of approximately 150 feet at selected intersections throughout the Township.

Supervisors Brian Budenski and Jeff Otto will again handle roads, but have organized their responsibilities differently for more efficient communication and coordination of contractor work and work load balance. Brian Budenski will handle Operations, dealing with day to day needs, coordinating resident issues and contractor priorities. He will be the primary public contact. Jeff Otto will focus on Planning, which includes budget issues and organizing detailed work information in a computer database to build toward the ability to forecast realistic 5-year plans. He will also serve as backup public contact when Brian may not be available on day to day issues.

A recommendation passed at the 2008 Annual Meeting was for the Board to expand the 2008 road program using all unspent 2007 road funds in addition to the 2008 road budget. The above list of road projects will be expanded once the Spring Road Inspection is made late on April 19th and projects are prioritized. This should allow expansion of the typical 5 miles of gravelling to 7-8 miles this year, depending on what the supplier and contractor bids come in at this year. This will recover most of last year's shortfall to restore the steady diet of replacement gravel our roads need to be as economical as possible to maintain stability. Last year's shortfall in gravel and limestone was due to planned diversion of funds for a one-time project, plus a reimbursement payment from Northern Natural Gas for excess road wear arriving too

late in the year to acquire and install additional gravel. The one-time project had to be cancelled late, thus the funds were not spent. Rather than risk two years in a row of deferred gravel maintenance, the project will be reconsidered for 2009.

Contact has already been made with Dakota County about the desire to be able to apply dust control prior to the Memorial Day weekend if we have another dry spring like last year. Eureka and other townships participate in a bulk order of dust control chemicals coordinated by Dakota County so that all may benefit from better volume pricing. This also means we do not directly control delivery, which comes from out of state by rail to Hastings. The County indicated they expect to be able to have chemicals available in May, but cannot guarantee delivery.

PLANNING COMMISSION MESSAGES

As always, this spring has been a busy one for the planning commission – even though spring weather has been late in coming. With the beginning of the construction season, building permit applications have increased. Remember that applications for building permits (as well as other permit applications) are due to the Town Clerk by noon ten days in advance of the Planning Commission meeting in order to be placed on the agenda.

Work continues on the Township's comprehensive plan update. The 2030 Comprehensive Plan Planning Committee has been holding monthly meetings since January. The committee will hold an **OPEN HOUGE ON APRIL 28** from 6 pm to 8 pm (**presentation at 7 pm**) at the Eureka Town Hall to update residents on progress to date. The Planning Commission is also wrapping up a review and update of Township ordinances. A public hearing on the proposed updates will be held soon. Watch the Township calendar or look for a public notice in the local *This Week News/Life and Times* newspaper for the date and time of the hearing.

Finally, I would like to thank the citizens of Eureka Township for the opportunity to serve you on the Planning Commission the last three years, and my fellow Commissioners for making my time on the Commission a rewarding and enjoyable experience.

NOTES FROM THE CLERK

Election Judges Needed – Two elections remain in 2008 - September 9 is the Primary Election, and November 4 is the General Election. Persons interested in becoming an election judge are encouraged to apply to the Town Clerk. General requirements include: 18 years of age or older (trainee election judges must be 16 or older), registered voter in the State of Minnesota, able to read, write and speak English, not be related to any other working election judge or candidate in that precinct. It is not necessary to be a resident of the polling place. Appointment of judges must be made at least 25 days prior to the election and training is required prior to working an election. Judges are compensated.
