This Year's Census Especially Important

The U.S. Constitution requires that a count of those living in the United States be taken every 10 years. 2010 is one of those years. For those living in Minnesota, this Census could be especially important. Fewer than 3,000 persons could determine whether Minnesota loses one of its eight seats in the

U.S. Congress as a result of greater growth in states in the southern parts of the U.S., despite population growth here in Minnesota. According

to Minnesota State Demographer Tom Gillaspy, in addition to deciding congressional seats, the Census numbers are used to determine distribution of more than \$400 billion in federal funding for everything from education to transportation. The business community also uses Census information for planning, marketing, labor force projections and more.

In mid-March 2010, the U.S. Census Bureau will mail a questionnaire to regular mailing addresses in the United States and hand deliver to those with a non-home delivery, i.e. P.O. Box. *U.S. Census forms will NOT be forwarded*. Each of those forms will contain a bar code indicating the address to which it is delivered. When you complete and return the questionnaire, the address that registers with the Census Bureau is that of the bar code. This causes particular concern for those such as snowbirds and others temporarily away from home. *It is imperative that you complete and return the Census form that is delivered to your normal home address, not a form from a temporary location*. If you respond to a Census form you receive at your "snowbird" address, you will be counted as a resident of that state, not Minnesota.

The 2010 version of the Census form will include 10 questions and take the average household about 10 minutes to complete. Filling out the form is required by law and privacy laws protect the answers for 70 years. For those of you who are genealogy buffs, the 1940 Census information will be available later this year.

TOWN BOARD NEWS

Township Road Concerns – Please contact Town Board supervisors Brian Budenski at 952-292-6028 or Dan Rogers at 952-469-3739 regarding any issues relating to Township roads or ditches, rather than the road contractors.

A Very Big Thank You - to Otte Excavation, the Township road contractors, for their excellent work all year long, but especially during the 2009 Christmas storms.

Road Parking Reminder – as listed in Ordinance 4, Chapter 2, Section 4.F., vehicles may remain parked on roads within the Township for **no more than 48 consecutive hours**.

Vermillion Watershed District – In the October 2009 edition of this newsletter an article about the VRWJPO *incorrectly* attributed a statement regarding federal buffer requirements to Carol Cooper. Please accept apologies for this misinformation.

Ballot Initiatives – The Township lawyer confirmed that under Minnesota Statute, there are very limited opportunities for residents to bring forth petitions resulting in referenda to be placed on any election ballot. Some of these circumstances include creating new powers, new taxes or bond issues. He is creating a table that will be available in the Town Hall outlining "initiative and referenda" opportunities under Minnesota law for public viewing.

CapX2020 Power Line - In November 2009 the Big Stone II coal-fired power project, proposed to be built near Brookings, South Dakota, was cancelled by its developers, citing a poor economy and concerns over upcoming federal carbon dioxide regulations. A number of the eleven original cooperating power companies had backed out of the project when they were unable to locate additional investors. While the CapX2020 high voltage power lines project was closely tied to the Big Stone II, the routing permit process is proceeding. The Minnesota Public Utilities Commission's (PUC) continued to hold public hearings regarding the proposed routes for the CapX2020 project through December 18, 2009, and allowed written public comment until January 15, 2010. Meanwhile, as previously reported, the Citizens Energy Task Force (CETF) filed a brief in October 2009 with the Minnesota Court of Appeals challenging the PUC decision to certify the CapX2020 projects and the La Crosse Project as well as increasing the size the CapX2020 lines. That appeal has not yet been heard. The Eureka Town Board did submit testimony opposing the proposed routing decision process, similar to testimony submitted opposing the permitting process.

Interceptor Sewer Line - At the November 2009 Town Board meeting, a resolution was passed to grant a Conditional Use Permit for a Sanitary Lift Station to be located at the northeast corner of Dodd Blvd. and 235th St. with access to this lift station to be via of 235th St.



Such a letter or e-mail should include contact information and a comment or two about why the writer is interested in serving on the Commercial/Industrial Task Force, and what they can bring to the discussion. Those submitting letters of interest will meet individually with the Planning Commission, with an April or May 2010 date anticipated.

Ordinance Update in Progress, Public Hearing To Be Scheduled - The Planning Commission and Town Board are completing a periodic review and update of the Township ordinances. Once this process is complete, a public hearing can be scheduled, posted and the proposed ordinance changes made available to the public at the Town Hall and through a link on the Eureka Township web site, http://eurekatownship-mn.us. Public hearing notices are posted on the Eureka Township web site; in ThisWeek Life and Times Newspaper; on the bulletin board located on the south side of the Town Hall; or you may contact the Town Clerk at eurekatn@frontiernet.net to request electronic notification.

Clarification of Some Minimum Distances Between Neighbors and Specialized Buildings

Candidates for Supervisor #5 Position - Three-year term to expire March 2013

The following candidates have applied for this year's Town Board Supervisor election (listed in alpha order):

Kenny Miller - Kenny is a graduate of Lakeville High School and the owner of Eureka Sand and Gravel. He was the Township road contractor for 17 years, a member of the Town Board for four years, and most recently, the Planning Commission for three years. During that time, he is pleased to have been instrumental in getting the "new" Town Hall built. The Comprehensive Plan, as well as, updating and clarifying ordinances are two areas he sees as upcoming work for the Town Board and to which he hopes to bring his lengthy experience assisting the Township as it grows into the future. Mr. Miller can trace his family's presence in Eureka Township back to the 1890's when his great-grandfather built a Dutch style windmill, resulting in the family's Swedish name being changed to Miller. He has lived here virtually all his life, with exceptions of early childhood and a stint in the U.S. Army. Currently, Kenny lives in the southeast quadrant of the Township on 267th St. W.

Christopher Prose - Chris has lived in Eureka Township for over 20 years, works for Terra Garden Center in Lakeville and is also a beekeeper. He feels we face many challenges moving into the new decade, and wishes to meet them head on. "One of the greatest challenges we face is the integrity of our border with Lakeville. Freedom is at risk in America. I do not believe in unnecessary regulation, and I certainly do not believe in ordinances that cannot be enforced. It is the right of the people to manage their own lives to the best of their ability, and as a supervisory council member, protecting that right, protecting that freedom, would be my most important duty."
