# Approval of the Agenda

### Clerk / Treasurer Book Review

Receipts: The Clerk's reported receipts totaled \$672,965.65. The Treasurer's reported receipts totaled \$634,897.52. The difference was the \$40,098.71 CD that was cashed in and CD interest totaling \$2,030.58.

# Review of the 2019 Budget / Recommended 2021 Levy

The Annual Meeting presentation does not include information that the Board increased the 2020 budget by 46% and is now increasing the 2021 budget an additional 18%. He would prefer to show justification for these increases considering we underspent the 2019 budget by \$30,428. Supervisor Hansen stated that the proposed levy has already been approved by the Board, we will present it at the Annual Meeting and let the citizens decide.

Julie Larson asked if the Clerk could post the proposed 2021 levy on the website to allow citizens to review the information before the meeting.
