## Call to Order

The Eureka Township Town Board meeting was called to order, via Zoom Meetings, at 7:00 p.m. by Chair Donovan Palmquist and the Pledge of Allegiance was given.

## Four wheeling on Township roads

Chair Palmquist reported that he received a call about a resident driving a four-wheeler on 265<sup>th</sup> St. W. The Sheriff's Department is requesting Ordinance information to cite the resident. Attorney Lemmons volunteered to send the information to the Sheriff.

# Complaint Follow Up

1. 10132 235th St. W. - Outdoor assemblies without a permit

Attorney Lemmons reported that the Sheriff went to the property and found that Ms. Petter was exhibiting animals and holding a swap meet. Ms. Petter is in contempt of the court order and in violation of the Township Ordinances.

*Motion:* Supervisor Barfknecht moved for Attorney Lemmons to cite Ms. Petter under the ordinance and to notify the court that she is in contempt of the court order, seconded by Chair Palmquist. A roll call vote was taken: Donovan Palmquist – Aye; Tim Murphy – Aye; Lu Barfknecht – Aye; Ralph Fredlund – Aye; Mark Ceminsky - Nay. *Motion carried 4-1*.

2. 7226 235<sup>th</sup> St. W. – Building without a permit Clerk Solis reported that Mr. Ceminsky submitted payment to renew his permit.

# 3. 24404 Iceland Path - Running a business without a CUP

Vice Chair Murphy reported that there is no sign of violation, the resident has removed the dumpster, sand mound, and there have been no employee vehicles parked in the cul-de-sac. Commission Chair Sauber pointed out that a home business cannot involve an accessory building and urged the Board to look into it further. Chair Palmquist and Vice Chair Murphy volunteered to speak with the resident and verify that there is no ordinance violation.

## 4. 24230 Holyoke Path - No fencing around pool

Vice Chair Murphy verified that there is no fence around the pool, and the resident has not responded to the building inspector's letter. Attorney Lemmons will draft a letter to the resident.

### Building Code and fee changes

Vice Chair Murphy reported that Inspectron is completing an update of all fees for the August Town Board meeting.

### Planning Commission update on General Code Legal Analysis review

The Clerk was directed to add a Round Table item to the August 24<sup>th</sup> Town Board meeting, and to inform the Planning Commissioners that their attendance is requested.

## Town Board Policies and Procedures, Code of Conduct

Clerk Solis reported that she has been unable to locate the documents. Supervisors Ceminsky and Barfknecht offered to locate an old copy and provide them to the Clerk.

# TKDA – Eureka Estates project update

Clerk Solis provided the Board with a copy of the letter and survey sent to the residents, and was asked to request TKDA attend the August 10<sup>th</sup> meeting.
