Policy for recording meetings

Opinion statement

Current policy: In the event a Town Board member is asked for an opinion on a specific matter, he/she must make it perfectly clear that any opinion given is only his/her opinion and not that of the

Board as a whole. Even though a Board member's opinion may be given, the issue would need to go before the Town Board for discussion and vote. An individual may not act upon one Town Board member's opinion. Discussion or communication on any matter can be discussed only between two Town Board members, as discussion or communication between three or more members of the Board constitutes a quorum and a violation of the open meeting law. The Building Official is the contact person if determination is needed regarding a building permit.
