# **Town Board Report**

## Roads Report

Supervisor Dan Rogers discussed the road work completed in 2016 and the 2017 Road Work Plan. He also discussed issues including debris pick-up, frost boil repair and sign replacement.

# **Proposed Joint Powers Agreement with City of Lakeville**

Supervisor Cory Behrendt discussed recent discussions with the City of Lakeville in regard to a joint powers agreement for water and sewer services for the Airlake Airport property. It was noted that a Boundary Protection Study had been conducted and an open house was held for interested citizens.

Allen Novacek, 24030 Iberia Avenue, discussed the need for the creation of a light industrial zone. He made a motion to direct the Town Board to pursue the creation of a commercial industrial zone in the area of the Airlake Airport property rather than risking the annexation of the property to the City of Lakeville. Mark Ceminsky seconded the motion.

Discussion was held in regard to alternative solutions to the sewer and water issue.

The question was called and a hand count vote was taken. The motion was defeated.

# Set Levy for 2017

Treasurer Marcia Wilson noted that the total Levy proposed for 2018 is \$465,500.

Motion was made by Andre Stouvenel, seconded by Earl Schindeldecker to adopt the 2018 Levy as presented. Motion carried.
