Chair Brian Budenski called the Special Meeting of the Eureka Town Board to order at 9:10 a.m.

To go into a closed meeting with Township Attorneys to discuss litigation with Country Stone.
Proposed time trials in Eureka Township

The open meeting was held in reference to go into a closed meeting about the Town of Eureka *vs*. Friedges Holding, Inc. and Country Stone and Soil of Minnesota, Inc., and in reference to Court File No. 19HACB093468. The purpose of going into closed session is to give an update concerning present negotiations with respect to the outstanding lawsuit.

Mr. Jeffrey Otto was present. He had been designated by the Town Board as a liaison in connection with the litigation and negotiation on this matter.

Supervisor Brian Budenski will let Silver Cycling know that the Town Board has given approval for its event.
