Motion by Supervisor Connie Anderson to make a log of keys issued for the Townhall. Make a key for Mike Greco for the envisioning committee. Motion seconded by Supervisor Donald Pflaum. Motion carried.

An article will be placed in the newsletter, describing the envisioning committee.

Frontier Communication requested permission to bury a cable along Denmark Ave. and 255th St. A motion by Supervisor Clark Smith, to grant permission, seconded by Supervisor Kenny Miller. Motion carried.

Nanett Leine will check with local townships on State Accounting Software. To aide in the decision on whether to purchase this program in lieu of the quicken payroll program. The State software program is put out to be used by small towns and cities for basic accounting and payroll.

Supervisor Don Pflaum motioned to send Nanett Leine to the Notary training seminar. Motion seconded by Supervisor Clark Smith, motion carried.

Nanett Leine will check with Township Association on audit policy.

Connie Anderson reported on RASP signs. It is an optional program. There is a charge for each sign. Included with sign are the nuts and bolts. Posts are not included. Township would need approximately 500 signs at a cost of \$3,500. Motion by Supervisor Kenny Miller: Each citizen, requesting a sign would pay for their own sign/optional post. Motion seconded by Supervisor Clark Smith, motion carried Connie Anderson will work out details on RASP signs for the next board meeting.

Mining Ordinance came back from the attorney, Townboard members will look over the document for approval at September board meeting.

Commercial Ordinance will be addressed at a special board meeting on Tuesday September 4th scheduled after the planning commission meeting.

Townboard addressed JS Rodeo. Informed them that Zoning code prohibits rodeos. It falls under public stable Section 4.62.5 public stables prohibited. JS Rodeo is non-confirming, and non confirming use cannot be expanded. Adding a rodeo would be considered expansion to the original use. The board invited Joe Simon to appear at the September board meeting to address this issue.

Nanett Leine will put together a public input card to be kept in a wall file near the entrance door. People wishing to be placed on the agenda will fill out this card. All handouts for the meeting will also be available in this file.

Connie Anderson reported on Fall Tire Collection. Motion by Supervisor Connie Anderson: To hold a tire collection on Saturday, October 6, 2001 for the community hours 9:00am to 5:00pm rain or shine. Motion seconded by Supervisor Don Pflaum, motion carried.

Motion by Supervisor Connie Anderson: Eureka requests a donation of 50 cents for small tires and \$1.00 for large tires. Motion seconded by Supervisor Clark Smith. Donation to support future tire disposal costs.

Wat Lao Temple is considering expansion. They requested procedure to follow. Board needs to see site plans, and they need approval by the shoreland zoning. The board discussed that under the current ordinance that they should be issued a CUP. Bev Topp will address Wat Lao on this issue.

Townhall future committee will be placed on the September agenda. Oliver Leine reported that public meetings and elections could be held up to 5 miles outside of township borders. It is also legal to lease space for these functions from religious organizations.

Mike Caron representing Barton Sand and Gravel addressed the board on the following issues. They will start mining gravel along 235th St. They will make berms along road and west property line approximately 43 feet from center line of road. They wish to widen the driveway, owned by MN DOT but used by them for access to their present mining area.

Motion by Supervisor Clark Smith: To grant expansion of driveway with (written permission) authorization from MN DOT indicating the approval of the expansion of the driveway. Motion seconded by Supervisor Don Pflaum, motion carried.

Motion by Supervisor Don Pflaum: To gravel Highview Ave. 240th St. to 250th St. and apply dustcoating full width. Motion seconded by Supervisor Clark Smith, motion carried.

Motion by Supervisor Clark Smith: To 1. Tile Fordham estimated cost \$1,500. 2. Tile 265th St. estimated cost \$740 3. Culvert on 265th mile west Denmark estimated cost \$1,600. Motion seconded by Supervisor Kenny Miller, motion carried, apposed by Supervisor Connie Anderson.

Motion by Supervisor Kenny Miller: To hold a public hearing at 8:00pm on September 4th, 2001. Asking the public to increase the levy, due to the reduction of HACA (Homestead and Agriculture Credit Aid) and LGA (Local Government Aid). Motion seconded by Supervisor Clark Smith. Motion carried.

Kenny Miller will check on the county gravel tax returns to the township. To help the board ascertain what use of the county formula would work best for the township.

Motion by Supervisor Don Pflaum to adjourn. Motion seconded by Supervisor Clark Smith. Motion carried.
