KADLEC MOVED TO ACCEPT THE TREASURE REPORT. SECONDED BY HELKENN AND CARRIED.

CLERK LEINE INTRODUCTED BILLS TOTALING \$14,125.07. HELKENN MOVED TO PAY THESE BILLS. SECONDED BY JOHNSON AND CARRIED.

DEAN MONSON, 10391 250TH ST.. REQUESTED A PERMIT FOR THE ADDITION OF A 300 SQUARE FOOT GARAGE AND 540 SQUARE FEET OF LIVING SPACE.

THIS PROJECT WAS VALUED AT \$30,595, CARRING A PERMIT FEE. OF \$291.00. HELKENN MOVED TO GRANT PERMIT, SECONDED bY KADLEC AND CARRIED.
