BILLS TOTALLED \$12,328.26. MOVED BY KADLEC, SECONDED BY CURRY, CARRIED.

PLANNING COMMISSION:

MIKE GILES, 10165 JAMAICA CT, LAKEVILLE, CAME BEFORE THE BOARD TO DETERMINE BUILDABILITY OF A LOT ON SIDNEY MOLLER FARM. MOTION MADE BY CURRY, SECONDED BY KADLEC TO LOCATE MOLLER HOUSE IN SOUTH 40 ACRES TO LEAVE THE NORTH 40 ACRES BUILDABLE FOR GILES.

TROY VAN GUINSVEN, 24220 HOLYOKE PATH, LAKEVILLE, CAME BEFORE THE BOARD TO GET A PERMIT TO BUILD A GARAGE. HAD BEEN BEFORE THE PLANNING COMMISSION ABOUT A YEAR AGO. THEY SENT HIM TO THE COUNTY WATER SHORELAND FOR A PERMIT. HE GOT HIS PERMIT FROM THE COUNTY SHORELAND IN OCT. 19, 1989. HAD NOT BEEN BACK TO THE PLANNING COMMISSION. MOTION MADE BY KADLEC, SECONDED BY CURRY TO GRANT PERMIT. FEE.OF \$96.50.

MOTION MADE BY CURRY, SECONDED BY KADLEC TO ACCEPT THE ROADS IN EUREKA ESTATES SECOND ADDITION.

IT WAS AGREED TO HOLD ANY FURTHER ACTION CONCERNING D. TOUSIGNANT UNTIL INSPECTOR MENKE HAS CONFIRMED WHETHER MR. TOUSIGNANT HAS VACATED THE GARAGE.

THERE HAVE BEEN SEVERAL INSTANTS OF FIRES WITHOUT PERMITS THAT HAVE BEEN SERVICED BY EITHER THE LAKEVILLE OR FARMINGTON FIRE DEPARTMENTS. THE TOWNSHIP LAWYER IS TO BE CONTACTED TO DETERMINE WHETHER THE TOWNSHIP CAN COLLECT THE FIRE BILL FROM THE OFFENDING HOME-OWNER.
