Hirschoff then brought up the matter of speed limit on township roads. The clerk and Robert Johnson pointed out that the town cannot set speed limits. His motion seconded by lee Topp passed and the board will see if anything can be done.

Robert Johnson said a bill to a moratorium on sludge and ash sites was still alive in the legislature.

Topp made a motion to send a letter to Senator Engler to not allow groups that are public funded to have lobbyist in the Met Council the legislature. Seconded by Cheryl Schindeldecker. No action taken.
