

EUREKA TOWN BOARD MINUTES FOR FEBRUARY 8, 1993

THE MEETING WAS CALLED TO ORDER BY CHAIRPERSON SCHINDLEDECKER. PRESENT WERE SUPERVISORS JOHNSON AND KADLEC, CLERK LEINE AND TREASURE SCHULZ.

JOHNSON MOVED TO ACCEPT THE MINUTES OF THE JANUARY AS READ BY CLERK LEINE, SECONDED BY KADLEC AND CARRIED.

KADLEC MOVED TO ACCEPT THE TREASURES REPORT AS READ, SECONDED BY JOHNSON AND CARRIED.

JOHNSON MOVED TO PAY THE BILLS THAT CLERK LEINE PRESENTED, SECONDED BY KADLEC AND CARRIED.

THE PLANNING COMMISSION HAD NO BUSINESS FOR THE MONTH OF FEBRUARY.

PAUL SMITH, 26480 GALAXIE AVE, WOULD LIKE TO STORE AND SELL AMWAY PRODUCTS FROM THIS LOCATION. PRODUCT WOULD INCLUDE FARM OILS, FERTILIZERS, AND OTHER FARM RELATED PRODUCTS. JOHNSON MOVED TO CHECK WITH ATTORNEY, IS THIS A PERMITTED BUSINESS OR NOT IN THE TOWNSHIP, SECONDED BY KADLEC AND CARRIED.

THE CHAIR, READ A LETTER INTO THE RECORDS FROM VALERIE J BRITTON, 24345 HIGHVIEW AVE. (COPY OF LETTER ATTACHED) BRITTON IS ASKING THE TOWNSHIP TO DO SOMETHING ABOUT THE TERRIBLE ROADS IN THE TOWNSHIP. THE CITIZENS AND THE BOARD HAD A LENGTHY DISCUSSION ON THE ROADS AND POSSIBLE SOLUTIONS. THE BOARD SAID THEY WILL MAKE AVAILABLE TO ANY RESIDENT A COPY OF WHEN THE ROADS ARE TO BE GRADED. CITIZENS AT THE MEETING ALSO TOLD THE BOARD THAT IF IT TOOK HIGHER TAXES TO GET BETTER ROADS, THEIR WERE WILLING TO PAY THE HIGHER TAXES. JOHNSON MOVED TO PLACE THREE (3) SIGNS ON HIGHVIEW AVE (SCHOOL BUS STOP AHEAD) TO WARN DRIVERS OF BUS STOPS. THIS MOTION SECONDED BY KADLEC AND CARRIED. THE TOWNBOARD ASKED THE CITIZENS TO ATTEND THE ANNUAL MEETING AND VOICE THEIR CONCERNS.

MAURIE MEYER TALKED TO THE BOARD ABOUT CONTROL OF WEEDS AND BRUSH IN THE DITCHS OF EUREKA TOWNSHIP. HE TOLD THE BOARD ABOUT CHEMICALS THAT DO NOT NEED SPECIAL CONTROL OR PERMITS THAT WILL DO THE JOB OF WEED CONTROL. MEYER TOLD THE TWP THAT JUNE WAS THE RECOMMENDED TIME TO SPRAY.

SHERI AND JEFF OLSON, 26400 IPAVA AVE, ASKED THE BOARD WHAT WAS NEEDED TO DO TO START A DOG KENNEL/DOG GROOMING OPERATION. THEY WOULD LIKE TO HAVE A CUP TO OPERATE A 10 DOG KENNEL/GROOMING BUSINESS. THE BOARD EXPLAINED THE C.U.P. PROCESS AND ADVISED THEM TO CHECK WITH THE COUNTRY AND STATE FOR ANY OTHER RULES PERTAINING TO THE KEEPING OF ANIMALS.

JOHN STRUNK, BROUGHT TO THE ATTENTION OF THE BOARD THE WAT LAO COMMUNITY SERVICES OF FEB.6. HE STATED THAT CARS WERE PARKED ON CEDAR AVE, THAT THE DRIVE WAY LEADING INTO THE WAT LAO COMMUNITY WAS FULL AND BLOCKED SO THAT NO EMERGENCY -VECHICLES WOULD HAVE

BEEN ABLE TO GET INTO THE MEETING AREA. STRUNK ASKED TO BOARD TO INFORM THE WAT LAO PEOPLE TO KEEP THIS AREA OPEN FOR THE OWN PROTECTION.

IT WAS BROUGHT TO THE BOARDS ATTENTION THAT THE JACK BURNETTE PROPERTY AT 225TH & ESSEX, HAD A LOT OF JUNK VEHICLES IN THE YARD AND IN THE WOODS BEHIND THE HOUSE. GEORGE JOHNSON TO SPEAK WITH BURNETTE'S WITH A FOLLOW UP LETTER FROM THE ATTORNEY IF NEEDED.

IT HAS BEEN SUGGESTED TO THE TOWNSHIP THAT THEY PASS A RESOLUTION MAKING THE CULVERT AREA BY KNUTSON ON IPAVA AVE. A BRIDGE. THIS WOULD REQUIRE A HYDROLOGY STUDY OF THE AREA. THE TOWN BOARD TO ASK OSM IF THEY CAN DO THIS.
