Call to Order

- Frontier Communications: an invoice was paid on January 25, 2021, where a balance forward was paid in addition to the current charges. The duplicate payment was credited in March of 2021, but the invoice was not retained for our records.
- TKDA: a payment was issued for the Eureka Estates project but no invoice was attached to the claim. Clerk/Treasurer Solis was able to locate the invoice in an email and attach a copy for our records.
