TOWN BOARD MEETING April 26, 2022 - 7:00 P.M.

Call to Order

The Eureka Township Town Board meeting was called to order at 7:00 p.m. by Chair Lu Barfknecht and the Pledge of Allegiance was given.

Supervisors Present: Lu Barfknecht, Ralph Fredlund, Nancy Sauber and Kathleen Kauffman.

Supervisors Absent: Donovan Palmquist.

Others Present: Ranee Solis, Randy Wood, Georgie Molitor.

Zoom Attendance: Gloria Belzer, Julie Larson, Deb Burkhardt.

Approval of the Agenda

The following changes were made to the agenda:

- 1. Add B. Culverts under Road Report.
- 2. Add I. Housing Rights Transfer text amendment follow up under Old Business.
- 3. Add B. Clerk review under Clerk Matters.
- 4. Add J. Furniture update under Old Business.
- 5. Add K. Inspectron update under Old Business.

Motion: Supervisor Sauber moved to approve the agenda as amended. Supervisor Fredlund seconded. *Motion carried 4-0.*

Public Comment

Chair Barfknecht opened the floor for public comment and reminded that if anyone has comment regarding any agenda items, now is your time to speak.

<u>Julie Larson – 24510 Highview Avenue</u>

Ms. Larson asked if the Board knew what the flags in the right-of-way on Highview and $250^{\rm th}$ were for. Supervisor Fredlund offered to check into it.

Georgie Molitor - 8875 225th St. W.

Ms. Molitor informed the Board that her family would be performing their annual Mother's Day ditch cleaning on $225^{\rm th}$ and asked where the bagged trash and junk should be placed

for pick up by the road contractor. She also noted that green plastic from Scotts Miracle Gro has been blowing onto her land and asked the Board to reach out to them.

Chair Barfknecht asked three times if there were any other attendees who would like to make comment. Hearing none, the floor was closed.

Road Report

<u>Dust control schedule</u>

The road supervisors will ask Mark Henry to provide a date range for dust control for posting on the website.

Culverts

Supervisor Fredlund received complaints regarding culverts on Fairgreen and 265th and will forward the information to Mark Henry.

Supervisor Fredlund noted that the fee schedule offers Township-provided culverts for \$450, however, the prices now are \$840 for steel and \$400-\$500 for plastic. He proposed the Board remove the Township-provided option and amend the fee schedule. In addition, the Ordinance does not specify if the culvert must be made of galvanized steel or whether plastic is an option.

Motion: Supervisor Sauber moved for the Clerk to draft a resolution amending the fee schedule by removing the option of the Township providing a culvert. Supervisor Kauffman seconded. *Motion carried 4-0.*

Treasurer's Report

Net pay and claims

The Clerk presented payroll in the amount of \$2,185.72 for payment.

Motion: Supervisor Sauber moved to approve the net pay and claims as presented. Supervisor Fredlund seconded. Roll call vote: Lu Barfknecht – Aye; Ralph Fredlund – Aye; Nancy Sauber – Aye; Kathleen Kauffman – Aye. *Motion carried 4-0.*

Annual CUP review: Spirit Ranch I - Chris Hale, 24005 Dodd Blvd

Motion: Supervisor Sauber moved to refund the \$10 overpayment on the CUP review. Supervisor Fredlund seconded. *Motion carried 4-0*.

Motion: Supervisor Sauber moved for the Clerk to send a letter to the Hales explaining that the dog kennel license fee does not have to be paid if the kennel is not active. Supervisor Fredlund seconded. *Motion carried 4-0*.

Motion: Supervisor Kauffman moved to table the review for Spirit Ranch I, and for the Clerk to include a request that they appear at the next meeting in the letter. Supervisor Sauber seconded. *Motion carried 4-0.*

Annual IUP review: MPM - Michael Callahan, 5100 235th St. W.

Motion: Supervisor Kauffman moved to table the annual review for MPM and extend it until the May 10th meeting. Chair Barfknecht seconded. *Motion carried 3-0*, with Supervisor Sauber recused.

Old Business

Fence Ordinance

Supervisor Fredlund explained that the purpose of the 2018 amendment to the fence ordinance was to change the word permit to administrative fence approval.

Supervisor Sauber expressed her objection to items being forwarded to the attorney without full Board approval. Chair Barfknecht pointed out that the Board approved for Supervisor Kauffman to manage the attorney and asked the Clerk to add general discussion of liaison duties to the next meeting agenda.

Motion: Supervisor Kauffman moved to accept the amended fence language and forward to the Planning Commission for a public hearing. Supervisor Sauber seconded. *Motion carried* 4-0.

Sheriff's Department - Deputy O'Meara

Julie Larson requested increased patrol of 250th between Dodd and Cedar from 4-6 pm due to racing.

Old Business - Continued

Mining Ordinance

Supervisor Kauffman presented a draft interim ordinance authorizing a study and placing a moratorium on the establishment of new mining facilities, as well as a draft resolution approving summary language for publication of the interim ordinance.

Supervisor Sauber questioned whether a moratorium on zoning requires a public hearing. Supervisor Kauffman offered to check with the attorney.

Motion: Supervisor Kauffman moved to adopt the Interim Ordinance authorizing a study and placing a moratorium on the establishment of new mining facilities, subject to a response from the attorney as to whether a public hearing is required. Chair Barfknecht seconded. *Motion carried 3-0*, with Supervisor Sauber recused.

Mining Engineer

Supervisor Kauffman offered to ask TKDA and Carrie Jennings to provide the scope of work.

<u>Text amendment regarding play structures</u>

Supervisor Kauffman presented two versions of a text amendment to Ordinance 3, Chapter 4. Section 7.

Version 1: adding to C. "nor shall one play structure be considered in the total sum of accessory buildings on an individual parcel"; and adding a definition of play structure to Ordinance 1, Chapter 4.

Version 2: changing C. Area – The maximum total area of all accessory buildings shall not total more than 5,000 5,200 square feet...".

Motion: Supervisor Kauffman moved to forward version 1 of the proposed text amendment to the Planning Commission for a public hearing. Chair Barfknecht seconded. *Motion withdrawn*.

Motion: Chair Barfknecht moved to add a definition to Ordinance 1, Chapter 4 for play structures. Supervisor Kauffman seconded. *Motion failed 2-2*, with Supervisors Sauber and Fredlund opposed.

Motion: Chair Barfknecht moved to send Ordinance 3, Chapter 4 to the Planning Commission to amend Section 7 C. as proposed. Supervisor Kauffman seconded. *Motion failed 2-2*, with Supervisors Sauber and Fredlund opposed.

Supervisor Sauber stated her reason is that 5,000 sq. ft. is a fair amount and there is no need to make an exception. Supervisor Fredlund agreed that there is no need for exceptions to the Ordinance.

<u>Text amendment Ordinance 2, Chapter 3</u>

Motion: Supervisor Kauffman moved to table the proposed text amendment. Chair Barfknecht seconded. *Motion failed 2-2*, with Supervisors Sauber and Fredlund opposed.

Motion: Supervisor Sauber moved to approve the text amendment as presented. Supervisor Kauffman seconded. *Motion failed 2-2*, with Supervisors Sauber and Fredlund opposed.

Recodification project

Motion: Supervisor Kauffman moved to approve the change order from General Code in the amount of \$888.00 to update the recodification to the 2017 code book. Chair Barfknecht seconded. *Motion carried 4-0.*

Closure of 245th at the Scott County border

Supervisor Kauffman reported the Township will not lose the easement by closing the road.

Supervisor Fredlund read Resolution 2022-04, temporarily closing 245th St. W., into the record:

Whereas the Town Board is the road authority for town roads in Eureka Township; and

Whereas the Town Board works with limited road and bridge funds set by a levy determined by the town electors at the annual meeting; and

Whereas the Town Board finds that 245^{th} Street is infrequently used and does not provide direct access to homes; and

Whereas the Town Board determines keeping $245^{\rm th}$ Street open would impose an unreasonable burden on the Town's maintenance funds given its low level of use and high maintenance cost; and

Whereas town boards have the authority to close and barricade roads.

Now, therefore, be it resolved, by the Town Board of Eureka Township, Dakota County, Minnesota that 245th Street within the boundary of Eureka Township shall be closed effective as of the date that the Township causes barricades and proper signage to be placed on said road and running until such time when Town Board determines that the road is needed to accommodate traffic and orders the barricades and signs removed.

Motion: Supervisor Fredlund moved to approve Resolution 2022-04 temporarily closing 245th St. Supervisor Sauber seconded. *Motion carried 4-0.*

Reschedule Round Table meeting

The Board agreed to present either May 26^{th} or June 9^{th} to the Planning Commission for the Round Table meeting.

Furniture update

Chair Barfknecht has been in touch with Mr. Malowitz, who worked with Mr. Lefave to build the original desks, to provide a quote to build two more desks.

Clerk Matters

<u>Clerk review</u>

The Board agreed to schedule a closed meeting on May 24, 2022, at 6:30 p.m. for the Clerk review.

All remaining agenda items were tabled until the May 10th Town Board meeting.

Motion: Chair Barfknecht moved to adjourn the meeting. Supervisor Sauber seconded. *Motion carried 4-0.*
