Commissioner Wood opened the floor for nominations for the 2021-2022 Planning Commission Chair. Commissioner Larson nominated Randy Wood for Chair, seconded by Commissioner Clancy. Hearing no others, the floor was closed for nominations. ### **Citizen Inquiry**

# <u>Dan Adelmann – Housing right determination</u>

Dan Adelmann requested a determination as to whether his 22-acre parcel with PID 13-00900-25-013 contains a housing right. Jeff Otto expressed his opinion that the quarter-quarter section currently contains a shared native housing right. The railroad right-of-way creates a split, thus creating a native right on both the Harmer parcel and the Adelmann parcel. Mr. Adelmann can create a shared driveway along the railroad tracks to his parcel containing the 100-ft frontage on Hamburg Avenue to meet the ordinance requirement.

Supervisor Sauber stated that the creation of a driveway by easement must be recorded at the County prior to issuance of a building permit. Jeff Otto added that a driveway must be in place in order to apply for a building permit, but does not affect the ability to transfer a housing right.

Commissioner Larson asked whether the intended lot split is time sensitive due to the pending annexation of the sending parcel into Lakeville. Jeff Otto responded that the housing right transfer must only be initiated within 30 days, and can be held for up to 90 days, to provide protection of the housing right from annexation. Mr. Otto requested permission to speak with the Township Attorney for confirmation, at the Adelmann's expense.

*Motion:* Chair Wood moved to authorize Jeff Otto to speak with Chad Lemmons regarding the Adelmann parcel with a response to be submitted in writing to the Clerk, seconded by Commissioner Larson. Roll call vote: Randy Wood – Aye; Julie Larson – Aye; Bill Clancy – Aye; Debra Burkhardt – Aye; Chad Berg - Aye. *Motion carried 5-0.*
